Smarter Insurance for Property Investors

This session looks at how to think about insurance risk as part of investment due diligence, by buying smarter in a changing risk landscape.

New Zealand's understanding of flood and earthquake risk has improved dramatically over the past decade, driven by better modelling, more granular data, and the hard lessons of recent events. The catch is that more accurate risk data tends to reveal more risk, not less.

It's also accelerating a shift away from community-based insurance pricing toward risk-based pricing, a change that has a reasonable fairness argument behind it, but carries real implications for which properties remain insurable, at what cost, and on what terms. For property investors, that means insurance can no longer be treated as a fixed cost in the spreadsheet.
